He reminded the Council Members that Article 5, Section 5.2 of the AIA Constitution stipulates that a two-thirds (2/3) vote of the total Council membership (29 members) is required to amend the AIA Constitution and that a two-thirds (2/3) vote of the members present at a duly called meeting is required to amend the AIA Bylaws. Chairman Wilkinson continued by stating that Article 4, Section 4.5 of the AIA Constitution stipulates that a quorum must be present at a meeting for the transaction of business, a quorum being two-thirds (2/3) of the total membership. He concluded that a quorum was present since roll call reflected that 37 of the 44 Council Members were present. It was also determined, based upon the 37 members present, that a vote of 25 would be required for adoption of amendments to the AIA Bylaws. Chairman Wilkinson then reminded the Council that in accordance with Article 4, Section 4.5, Paragraph 4.5.5 of the AIA Constitution, proxy votes couldn't be accepted.

WHEREAS, the Arizona Interscholastic Association, Inc. shall oppose all efforts of any organization, agency or individual to establish such competition;

THEREFORE, BE IT RESOLVED, That the Arizona Interscholastic Association, Inc. urges high school administrators and coaches throughout the state to (1) decline any invitation to participate in all-star competition; (2) refrain from recommending any student athlete for all-star competition; and (3) refuse to provide use of any high school facility for all-star competition, except for those activities sanctioned by the AIA Executive Board.

## 14.7.1 POSITION STATEMENT

The member schools of the AIA oppose all-star competition during the school year and shall oppose all efforts of any organization, agency or individual to establish such competition.

14.7.2 During the school year, administrators and coaches shall decline any invitation to participate in all-star competition, shall refrain from recommending any student athlete for all-star competition and shall refuse to provide use of any high school facility for all-star competition, unless specifically sanctioned by the Executive Board.

#### **ARTICLE 14 – GENERAL PROVISIONS**

### 14.14 PREVENTION OF EXERTIONAL HEAT ILLNESSES

#### 14.14.1 AIA POSITION STATEMENT

It is the position of the AIA that prevention is the best way to deal with heat illness. Prevention includes educating athletes and coaches regarding: recognition and treatment of heat illnesses; risks associated with exercising in hot, humid environmental conditions; the need for gradual acclimatization over a 10 to 14 day period; guidelines for proper hydration; and following practice/competition modifications based on the local temperature and relative humidity readings.

In determining safe competition, the air temperature and relative humidity (RH) must be identified and used to determine whether or not practice/competition should be modified, postponed or cancelled (rescheduled). Many times it is the RH and not the temperature that is the determining factor. There are three different zones (below danger zone, danger zone and critical zone).

The Certified Athletic Trainer and/or the site administrator at each school are responsible for determining these zones from the combination of the most current temperature and humidity readings. Predictions regarding the readings may need to be conducted to ensure safe competition. In this case, utilize the maximum temperature and RH reported for the practice/event start time.

If the source of the temperature reading is in question, it is advised to be conservative and follow the modifications of the higher zone. Temperature measurements can be obtained by using a sling psychrometer or from various internet weather-related sites such as: www.weather.com or www.noaa.gov.

Example: 105 deg. F. + 35% RH = 140 (Danger Zone)

## **Below Danger Zone (Under 135)**

- Practice/competition as normal
  - Full pads
  - Regular running schedule (football, cross-country)
  - Water breaks every 15 minutes or as needed by the individual

## **Danger Zone (136-145)**

- Practice/competition with modifications
  - o Reduced amount of equipment worn
  - o Adjust start time until readings return Below Danger Zone
  - o Reduced running schedule
  - Water breaks every 10-15 minutes or as needed by the individual

## Critical Zone (146 and above)

- Practices modified; competition postponed or cancelled/rescheduled
  - No equipment worn
  - o No running
  - Water breaks every 10-15 minutes or as needed by individual\
  - Practice moved indoors
  - o Practice or competition postponed until reading returns to Danger Zone
  - Practice or competition moved to a later date or time
- 14.14.2 Schools shall cooperate in an effort to comply with AIA Bylaw 14.14.1. A school postponing or canceling a contest in compliance with AIA Bylaw 14.14.1 shall not be in violation of AIA Bylaw 14.4.3 Cancellation Or Postponement Contest Or Program. The affected schools shall cooperate in the rescheduling of that contest.

  - 15.14.6 Upon request by the Executive Director or designee, the sending school shall provide a representative during the hardship appeal hearing(s) before the Hardship Appeals Committee and/or the Executive Board. Failure of the sending school representative to attend shall not prevent or otherwise delay any hearing or decision on the appeal, but the failure to appear may be considered a violation of the AIA Bylaws and may result in sanction as determined by the Executive Board.

## 16.3 SPORTSMANSHIP RULE

- 16.3.2 <u>Leaving Bench Area</u> When two or more persons (including coaches, nonplaying contestants and nonparticipating school personnel) leave their team's bench area to initiate a confrontation, or during an altercation in progress, the following shall occur without appeal:
  - 16.3.2.1 The contest officials shall eject any person they determine to be in violation of Article 16, Section 16.3, Paragraph 16.3.2 of the AIA Bylaws.
  - 16.3.2.2 The contest officials may terminate the contest.
    - 16.3.2.2.1 If the contest is terminated, the team(s) that left the bench area must forfeit the contest and record a loss.
    - 16.3.2.2.2 If the contest is terminated during a tournament or post-season play, the offending team(s) will be removed from further tournament or post-season competition.
  - 16.3.2.3 Further penalties may be imposed against the offending team(s) by the AIA Executive Board, as set forth in Article 16, Section 16.1 of the AIA Bylaws.
  - Spectator Behavior In the event that spectators, parents, or other non-school personnel initiate or engage in physical conflict or other threatening or aggressive behavior with officials, players, coaches, or other spectators, the school(s) involved shall utilize all available law enforcement resources to prosecute such offenders, and shall take all reasonable actions to help ensure that future similar incidents do not occur, such as temporarily or permanently prohibiting the offender(s) from attending future contests.
- 16.3.3 ENTERING SPECTATOR AREA PROHIBITED No player may leave the playing area and enter the spectator area of the facility to engage in any type of verbal or physical conflict. Notwithstanding any other rule in the Constitution and Bylaws, the MINIMUM penalties for violation of this rule are:
  - <u>The player is ineligible to participate in all interscholastic athletics</u> for the remainder of the school year, and;
  - The player's school shall immediately be on Probation pending an investigation and report by the school to the AIA detailing what occurred, what caused the occurrence, what was done by the school to diffuse what occurred, what school imposed disciplinary actions have occurred, and what corrective actions have been implemented by the school to prevent future violations. In the discretion of the Executive Director, a school's report may be rejected if deemed inadequate and the Probation shall remain in effect pending receipt of an adequate report.
