

ARTICLE 17**COACHES AND COACHING**

- 17.1 **COACHING QUALIFICATION – All head and assistant coaches, whether paid or volunteer, hired before April 1, 2009, must complete the NFHS Coach Education Program, or approved equivalent, no later than the beginning of the 2009-2010 school year. All head and assistant coaches, whether paid or volunteer, hired on or after April 1, 2009, must complete the NFHS Coach Education Program, or approved equivalent, within forty five (45) days from the date of hire.**
- **The AIA Executive Board recommends the NFHS Coach Education Program (NFHS Fundamentals of Coaching) which satisfies all requirements including verification of completion.**
 - **The AIA Executive Board will review and approve coach education courses, for purposes of satisfying the AIA Coach Education requirement based on the national standards by the National Association for Sport and Physical Education.**
- 17.1.1 Coaches shall be approved in accordance with the personnel policies of the school district and in accordance with the Arizona Revised Statutes.
- 17.1.2 All head varsity coaches shall have a valid Arizona Teaching Certificate or Arizona Coaching Certificate on file or recorded in the office of the principal or his/her designee.

- 17.1.3 Any and all salary or remuneration shall be from the school district by which the coach is employed and no salary or remuneration for school coaching shall be from any outside source.
- 17.1.4 The following regulation will apply to all paid, volunteer and student teacher coaches.
- 17.1.4.1 Any violation during competition, a state qualifying meet or state tournament may result in the forfeiture of the contest, elimination of that team or individual from that tournament as recommended by the Tournament Director and Tournament Games Committee, and/or such other penalty as the AIA Executive Board may impose. (See Article 16, Section 16.1)
- 17.1.5 Candidates for teacher certification doing practice teaching at a member school may be used as student teacher coaches during their assignment as practice teachers.
- 17.1.6 Provisions of Paragraphs 17.1.4 and 17.1.5 above shall not be interpreted to exclude a teacher employed in grades one through eight, inclusive, from being a high school coach. Such a person shall enter into a separate formal contract with the high school governing board.
- 17.1.7 Non-certificated personnel may be assigned as assistant coaches. Non-certificated personnel may serve as head freshman or junior varsity coaches under the supervision of an Arizona certificated teacher. Supervision shall be as defined by the Arizona Revised Statutes.
- 17.1.7.1 Prior to commencing coaching responsibilities, non-certificated personnel must be approved by the local school administration pending final approval at the next regular meeting of the school governing board.
- 17.1.8 **Coaches / Players** - Contest participation outside the season of sport between coaches and players of a single school for fund raising or entertainment purposes will not jeopardize the eligibility of a high school player.

17.2 COACHING DURING PRACTICE / COMPETITION

17.2.1 During interscholastic practices or contests only school authorized coaches are to coach, except as stated in Section 17.3, Paragraph 17.3.1 of this Article.

17.2.2 A school authorized coach shall be in attendance during all tournament warm-ups.

DETERMINATION:

Q: May a high school speech team or individual be coached by other than school personnel?

A: No. The AIA Executive Board determined that speech directors and assistants shall comply with Article 17, Section 17.1. (Ex. Bd. 8/77)

17.3 COMPLETION OF CONTEST - EJECTION OF COACH

17.3.1 When a coach is ejected from a contest, a properly constituted school administrator or assistant coach shall direct and supervise the team during the remainder of the contest. If no properly constituted school administrator or assistant coach is available to direct the team, the official shall declare the contest a forfeit.

17.3.1.1 The ejected coach shall immediately vacate the premises.

17.3.1.1.1 Premises are defined as the total area of contest and spectators. The ejected coach may not remain to watch the contest.

17.4 COACH'S / SPONSOR'S CODE OF ETHICS

17.4.1 Schools have entrusted coaches to provide the educational development of their youth through athletic and/or nonathletic activities.

17.4.2 In recognition of these expectations, it shall be the responsibility of a coach to follow the directions provided in the following Coach's Code Of Ethics. Violations of the first two items of the Code may result in a sanction to the offending school.

17.4.3 A COACH / SPONSOR SHALL:

17.4.3.1 Abide by the National Federation and AIA rules in both spirit and letter.

17.4.3.2 Not make statements to the news media critical of any game official, the AIA or another school's team, players, coaches or administrators.

17.4.3.3 Ensure that the Recruitment Rule defined in Article 15, Section 15.12 is honored by everyone associated with their program.

17.4.3.4 Coaches and/or game management personnel will not manipulate or control the environment or game conditions to gain an advantage over an opposing team or individual.

17.4.4 A COACH / SPONSOR SHOULD:

17.4.4.1 Cooperate with others in the field of education.

17.4.4.2 Exemplify behavior that is a credit to the teaching profession.

17.4.4.3 Exercise patience, tolerance and diplomacy in relations with all players and co-workers, contest officials and spectators.

17.4.4.4 Adhere to high ideals of sportsmanship: quality of cooperation, courage, unselfishness and self-control; desires for clean, healthful living; and respect for wise discipline and authority.

17.4.4.5 Support all reasonable moves to improve athletic conditions, to provide for adequate equipment, and to promote the welfare of an increased number of participants.

- 17.4.4.6 Demonstrate high ideals, good habits and desirable attitudes in professional behavior, and demand the same standards of the players.

17.5 **OPEN FACILITIES**

- 17.5.1 The AIA Executive Board has established the following guidelines relative to open facilities programs conducted by member schools. These open facilities guidelines are not intended to restrict or limit member schools' ability to rent or lease their facilities.
- 17.5.1.1 Member schools may open their gymnasiums and other athletic facilities under the direction of the principal or designee for recreational activities to students without being in violation of AIA Bylaws under the following guidelines:
- 17.5.1.1.1 The facility is open to all students enrolled in that school for participation. Opening facilities for a select group of students to practice individual skills for a specific sport is a violation of this policy.
- 17.5.1.1.2 Students not enrolled in a school may not be permitted to participate in recreational activities offered by that school.
- 17.5.1.1.3 Supervision by school personnel is required. However, school personnel, including faculty and non-faculty coaches in attendance, may not provide coaching or instruction in the skills and techniques in any sport. Their presence may be in a supervisory capacity only.
- 17.5.1.1.4 Participation is free of charge, voluntary and is not required directly or indirectly for membership on a team.
- 17.5.1.1.5 No select group of skills or interval training schedules, except weight training, may be assigned to students to perform.
- 17.5.1.1.6 The school administration assumes the responsibility for making certain that there is adherence to these guidelines.

DETERMINATION: *For purposes of 17.5.1.1.1 and 17.5.1.1.2 only, students of a feeder school for a member school, and home school students that the member school reasonably believes are in compliance with ARS §15-802.01, are considered "enrolled" at that member school and may be allowed to use that member school's open facilities. (Ex. Bd. 5/19/03)*

DETERMINATION: *The open facilities rule does not alter or amend any rule providing that AIA shall not have regulations concerning coaches coaching their own school teams during summer vacation period. (Ex. Bd. 5/19/03)*
