MEMBERSHIP COMMENTS

Mr. Kipper, Principal from Mountain Pointe High School, addressed the Board. Mr. Kipper noted that after 33 requests, he is still unable to complete his football schedule and is currently without full schedules for five (5) other sports.

EXECUTIVE DIRECTOR REPORT

Discussion was held at length regarding schedules. In order to finalize schedules, Mr. Bolitho will arrange a meeting with conference chairs to fill schedules. On a motion duly made, seconded and carried, the Board gave formal direction to staff regarding the following scheduling process:

- Schedule schools within Division by closest geographic location
- If schools have scheduled lower divisions, games will be unscheduled and schools placed in appropriate division
- Out-of-state games will be addressed
- Goal by the end of March all schools will have a full football schedule
- Extend deadline to March 28th for all other team sports (spring breaks)
- No appeal process

Rankings were discussed with the Board. Dr. Slemmer gave a brief history of the ranking process. It was noted that Colorado, New Mexico, CIF City Section, Georgia & Nebraska currently use MaxPreps and do not include forfeits in their rankings. The Board noted that they are concerned with the ethical culture of schools manipulating schedules & games resulting in cancellations and forfeitures. Membership was reminded to refer to the following link for information regarding the formula that determines AIA seedings powered by MaxPreps: http://www.aia365.com/rankings/faq.

Dr. Slemmer shared Indiana's team sports reclassification – tournament success factor information with the Board. Dr. Slemmer noted that before the next scheduling block (2015-2017), it could be reviewed as a possible alternative.

Dr. Slemmer thanked Mr. Schmidt and Mr. Mignella for their efforts in addressing the RefPay concerns which, it appears, will be resolved by legislation. It was noted that RefPay is beneficial to schools who participate in the service.

The large number of Arizona and out-of-state teams participating in baseball & softball tournaments was addressed. Assigning officials for these tournaments has become difficult. It was noted that the Officials Department's first priority is to honor Arizona scheduled games before trying to assign dozens of tournament games. Future bylaws changes may be needed to address the number of games allowed in a tournament.

Dr. Slemmer shared Dr. Beverly Hurley's notice of resignation as the 3A Conference Board member. Dr. Hurley announced her retirement on June 30, 2013. Applications for the 2013-2015 3A Board seat will now be accepted – deadline to apply is April 11, 2013.

The future Focus/Advisory Group was discussed with the Board. Names will be submitted to the Board in April and the committee will be engaged in May or June and will start officially meeting in August.

14.4 NONSCHOOL PARTICIPATION

14.4.1 A student who is a member of a school team shall not practice or compete with any other group, club, organization, association, etc., in that sport during the interscholastic season of competition. This rule applies to team sports only, which are football, baseball, basketball, volleyball, soccer, softball, track relay and swimming relay teams. For purposes of this rule, the interscholastic season of competition shall begin with the first regularly scheduled game and conclude with that particular team's final game. Any student violating the above rule shall forfeit his/her eligibility for a minimum of the balance of the season for that sport or up to a maximum of one calendar year.

SCHOOL VIOLATIONS

VERITAS PREP ACADEMY reported a violation of the AIA Bylaws; namely,

Article 14. General Provisions, Section 14.14 Concussion Education

Reported Violation:

Ineligible boys' basketball player. Student-athlete did not complete the Brainbook concussion course and participated in varsity basketball games in the 2011-2012 and 2012-2013 seasons.

School's Corrective Action:

Contests forfeited. Findings were discovered through an investigation on 2/8/13. We have created a new checklist and form procedure that will assist in preventing this oversight in the future.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Veritas Prep Academy **Activities Program** on **Advisement** for one year 3/18/13-3/18/14.

<u>MESQUITE HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, Article 15. Student Eligibility Rules, Section 15.1 Student Eligibility Requirements

Reported Violation:

Ineligible girls' tennis player. Student turned in her athletic packet and was not given proper clearance slip due to missing paperwork. She was given direction by the athletic department as to the process to become cleared. The student never did complete it and was never cleared. Upon submission of the roster from our tennis coach, it was discovered that she was allowed to participate in practice and 4 JV tennis matches.

School's Corrective Action:

Contests forfeited. The girls' tennis coach is a first time head coach. The A.D. met and went over the proper district clearance process again and explained the ramifications of not following that process. Submission of team members should be provided prior to the 1st practice and the coach match corresponding clearance slips with students in attendance.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Mesquite High School **Girls' Tennis Program** on **Warning** for one year 3/18/13-3/18/14.

<u>PALO VERDE HIGH MAGNET SCHOOL</u> reported a violation of the AIA Bylaws; namely, <u>Article 15. Student Eligibility Rules, Section 15.7 Physical Examination Rule, Section 15.8 Parental or Legal</u> Guardian Consent Rule

Reported Violation:

Ineligible softball player. Coach allowed a student to participate in practice for three days at the start of the season. Student did not turn in participation packet until Friday of the first week of the season. Coach failed to check the roster provided daily by the A.D. to verify that students were on the roster.

School's Corrective Action:

Practice only. A letter of direction was provided to the coach. All coaches were instructed at the beginning of the season of the clearance process. Coach was again instructed on clearance process. Coach takes full responsibility for the error.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Palo Verde High Magnet School **Softball Program** on **Warning** for one year 3/18/13-3/18/14.

<u>PEORIA HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, Article 16. Penalties & Appeals, Section 16.3 Sportsmanship Rule

Reported Violation:

J.V. boys' basketball game with Sunnyslope – all players from team left the bench area due to a physical altercation on the court. Both benches cleared and the game was called with four (4) minutes left on the clock.

School's Corrective Action:

Players in-serviced with the coaches in attendance in regards to not leaving the bench area when an altercation occurs on the court between players. Since this was the last game of the season, all six players ejected from this game will be required to sit out the first game of their next season. All players ejected are participating in a spring sport and will be required to sit out the first contest of the season. Athletic office will notify coaches of action.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Peoria High School **Boys' Basketball Program** on **Advisement** for one year 3/18/13-3/18/14.

<u>LIBERTY HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, Article 16. Penalties & Appeals, Section 16.3 Sportsmanship Rule

Reported Violation:

Boys' varsity basketball players left bench during game with Raymond Kellis. Based upon our investigation of the incident which involved interviewing players, coaches and spectators, we met with our team and suspended all bench players for participation in the next game. Since no players were identified by officials specifically, we determined who was on the bench by who was not on the court, and complied with the officials' request to allow no substitutions at the start of the fourth period. From all accounts, the incident occurred right in front of our bench area, as described, when two players became entangled and fell to the floor. The only physical contact made by anyone in the bench area was by the Kellis player #50, when he was being separated by our coach, and then shoved our coach. All witnesses stated there was no physical interaction between any other players of the two teams following the initial shoving of the coach, for which #50 Kellis player received a second technical and ejection. In fact, everyone (coaches and spectators) praised the Kellis administration, AIA officials, Glendale Police, game security and coaches for preventing spectators to become involved and preventing the teams from any physical interaction. Both teams were then kept in the respective bench areas, as the officials discussed the situation. The officials informed our coach, the bench players would be restricted to the bench for the remainder of the game, and play would continue for the fourth period. Both coaches agreed that the two teams would shake hands prior to resuming the fourth period and #50 apologized to our coach. Our coach accepted his apology and shook his hand. The game was completed without incident. In addition, our coaches addressed our fans as to their behavior for the remainder of the game as well. Both teams shook hands at the end of the game.

School's Corrective Action:

Contest not forfeited. Administration has met with coach and a designated bench coach has been assigned. Players have met with Administration and coaches to review Article 16.3.2.1 and compliance reinforced.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Liberty High School **Boys' Basketball Program** on **Warning** for one year 3/18/13-3/18/14.

RAYMOND S. KELLIS HIGH SCHOOL reported a violation of the AIA Bylaws; namely, *Article 16. Penalties & Appeals, Section 16.3 Sportsmanship Rule*

Reported Violation:

Boys' varsity basketball players left bench during game with Liberty. Kellis Administration investigated the incident by interviewing the coach, individual players, and one of the referees. At the end of the third quarter during the Thursday, January 10th boys' basketball game between Kellis and Liberty, we determined that two players, including Kellis #50, became entangled in front of the Liberty bench, but did not actually engage in a fight. The Liberty head coach and the officials separated the two players, and the officials assigned technical fouls for both the Kellis #50 and the Liberty player. There were no further physical interactions other than #50 shoving Liberty's head coach, for which #50 received a second technical foul and was ejected.

Because members of both teams left the bench to assist in separating the players, the officials disqualified both benches from the remainder of the game. Both teams shook hands, the Liberty coach and Kellis #50 shook hands, and the game was completed without incident, the players again shook hands after its completion.

On Friday morning following Thursday night's game, we sought clarification from the lead official as well as AIA Commissioner of Officials, Gary Whelchel regarding the referees' decision to disqualify all players on both benches. Both Kellis and Liberty administrations held meetings with their teams and coaches, reviewed the applicable bylaws and consequences, and finally suspended their benches for the games that took place that evening. Friday, January 11th, between Kellis and Copper Canyon and Liberty and Thunderbird.

School's Corrective Action:

Contest not forfeited. Kellis administration reviewed the bylaws and the consequences in a meeting with the team and coaches and suspended bench players for the next game.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Raymond S. Kellis High School **Boys' Basketball Program** on **Warning** for one year 3/18/13-3/18/14.

<u>CIBOLA HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, Article 16. Penalties & Appeals, Section 16.3 Sportsmanship Rule

Reported Violation:

On 2/7/13, wrestler was involved in an altercation in the stands of the Tim's Toyota Center. The altercation took place after his second round match of the AIA 2013 state wrestling championship and involved an assistant coach from Perry High School. The coach, from the stands, reportedly addressed the referee multiple times during the match in regards to calls that should go against athlete. At the end of the match, student disagreed with the match deciding call and threw his head gear. The assistant coach from Perry yelled "that should be at team point." According to several witnesses, student proceeded to make profanity laced remarks to the coach from the center of the mat. After a brief exchange of words, student left the mat and attempted to enter the stands to confront the coach. To get into the stands, student had to break through coaches and fans that were restraining him, as well as jump a wall approximately three feet high. After he reached the fan, student continued to make threatening remarks and gestures to the assistant coach. According to at least one witness, student placed his hands on the throat of a parent that was attempting to diffuse the situation.

School's Corrective Action:

Based on student's actions, he violated the student code of conduct by challenging to a fighting, verbal abuse and defiance of authority. All three violations are considered Class II violations. Since student was under the jurisdiction of the Yuma Union High School District, he is being long term suspended through May 24, 2013. The administration is also enacting the "exclusion clause" that would limit student's participation in extracurricular activities for up to two calendar years until permission is requested of, and granted by, the campus administration.

Coaches will be trained in efficient ways to promote sportsmanship within their programs. The techniques taught in the trainings will be expected to be implemented and embedded in all team activities

All security guards and game management personnel will be trained in deescalating situations before they turn violent. These practices will be incorporated into the standing operating procedure of Cibola Athletics.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Cibola High School **Wrestling Program** on **Warning** for one year 3/18/13-3/18/14.

HAMILTON HIGH SCHOOL reported a violation of the AIA Bylaws; namely,

Article 18. Officials, Section 18.1 Registration, Requirements & Qualifications

Reported Violation:

On 12/4/13, Hamilton had a home JV boys' soccer game schedule versus Corona. AIA referees did not show for the game, so one of Hamilton's coaches refereed the match. The coach had experience as a ref and participated in the soccer academy referee certification program held at Hamilton.

School's Corrective Action:

We will not longer use referees for JV boys' soccer games that are not assigned by the Commissioner of Officials.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Hamilton High School **Boys' Soccer Program** on **Advisement** for one year 3/18/13-3/18/14.

VISTA GRANDE HIGH SCHOOL reported a violation of the AIA Bylaws; namely, Article 36. Spiritline, Section 36.10 Coaches / Coaching

Reported Violation:

Spiritline – On January 10th at an away boys' basketball game, our spiritline was observed twist cradling and tumbling on a concrete tile floor outside of the gym. This surface was not an approved surface and the coach overlooked the athlete's safety by allowing the Spiritline to practice on this surface.

School's Corrective Action:

Coach received letter of direction (attached).

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Vista Grande High School **Spiritline Program** on **Advisement** for one year 3/18/13-3/18/14.
