



**VERIFICATION OF FACULTY MEMBERS
PRIVATE, PAROCHIAL, BIA, COLLEGE PREPARATORY & SPECIAL FUNCTION SCHOOLS**

PURPOSE OF FORM: This form is used by private, parochial, BIA, college preparatory and special function schools who are full members of the AIA to verify that faculty members have met the appropriate standards. In accordance with Article 3 of the AIA Constitution, verification must be submitted to the AIA by **September 1** of the current school year. (See reverse side of this form for list of non-public AIA full member schools.)

APPLICABLE AIA BYLAWS

- (1) Article 3, Certification of Staff, Section 3.1, Private, Parochial or BIA Schools, Paragraph 3.1.1: Private, parochial or BIA member schools shall notify the AIA Executive Director by **September 1** of the current school year that the entire faculty and staff have met the standards as set forth by the Arizona State Department of Education and/or the Arizona State Committee on Accreditation.
- (2) Article 3, Certification of Staff, Section 3.2, College Preparatory Schools, Paragraph 3.2.1: College preparatory schools which receive North Central Association accreditation shall notify the AIA Executive Director by **September 1** of the current school year that principals, coordinators, instructors and supervisors have met the appropriate North Central Association requirements.
- (3) Article 3, Certification of Staff, Section 3.3, Special Function Schools, Paragraph 3.3.1: Special function schools shall notify the AIA Executive Director by **September 1** of the current school year that the principal, coordinators, instructors, supervisors and the entire faculty and staff are appropriately certified in accordance with the Arizona State Department of Education or meet National Accreditation Council criteria, and have the approval of the Arizona State Committee on Accreditation.

NOTE: Verification must be received in the AIA Office by **September 1** of the current school year.
