2. **CONTACT** your Area Commissioner prior to the start of each sport.
3. **OFFICIALS MOVING INTO THE STATE WITH EXPERIENCE** will be classified as a Level 5. When the AIA receives a local test score, attendance of meetings, letter from previous State Association, and local evaluations, adjustments in your classification may be made.
