

**AACCA Safety Certification Course**  
**&**  
**NFHS Rules Interpretation Course**

**Registration Process**

**The following required courses will be held at the AIA office located at 7007 N. 18<sup>th</sup> St. (NW corner of the SR51 & Glendale Ave.), unless noted otherwise.**

**\*\* NOTICE....*A school's Spiritline team will NOT be allowed to stunt, tumble or compete during the season of activity until ALL Spiritline/Cheer/Pom coaches (paid or volunteer, head coach, assistant coach, varsity, JV, Freshman, etc.) are AACCA Safety Certified (with proof provided) and the coaches have attended a NFHS Spirit Rules Interpretation Course. (Coaches are to take the two required courses through the AIA).***

- AACCA Safety Certification is valid for **FOUR YEARS (Cost: \$75)**

- This course may be taken online ([www.nfhslearn.com](http://www.nfhslearn.com)) **only if the following criteria is met:**
  - o Spiritline coach is renewing certification and has taken the course prior through the AIA.

**\* NOTE: ALL NEWLY HIRED coaches (non-renewal) MUST attend the course in person through the AIA.**

- NFHS Spirit Rules Course must be taken **EVERY YEAR (Cost: FREE)**

- This course may be taken online through a webinar **only if the following criteria is met:**
  - o Spiritline coach attended the NFHS Spirit Rules Course in 2010 through the AIA.

**\* NOTE: ALL NEWLY HIRED coaches (non-renewal) MUST attend the course in person through the AIA.**

**\*\* NOTE: All Spiritline coaches MUST also take the NFHS Concussions in Sports FREE online course at [www.nfhslearn.com](http://www.nfhslearn.com) \*\*** (This is a one time completion course)

## What to do:

1. Find a date that is good for you to take the AACCA Safety Certification Course and/or the NFHS Spirit Rules Interpretation Course. *(Keep in mind that your team will **NOT be allowed to stunt/tumble or compete (from the first week of permissive football-August 1) until ALL Spiritline coaches have taken the two required courses and completed the Concussions in Sports online course.**)*

3. **FAX** your Purchase Order to Michele Staples at 602-385-3779 by the **DEADLINE DATE**.  
**\*\* NOTE: You will NOT be allowed to register AFTER THE DEADLINE DATE POSTED FOR EACH SESSION \*\***
4. **PAYMENT:** Please bring payment with you on the COURSE DATE **(DO NOT MAIL PAYMENT)**
5. **NOTE:** If you are already AACCA Safety Certified, you will just need to supply a copy of your certification to your Athletic Director and the AIA (Attn: Michele Staples) and take the NFHS Spirit Rules Course ONLY.
6. A confirmation email will be sent to each registered coach with more details *after each deadline.*
