#### Naturopathic Physicians: (Dr. Pam Howell)

- Dr. Pam Howell addressed the committee about allowing Naturopathic Physicians to perform Pre-Participation physicals.
- After discussion, the committee asked for documentation about competency base and scope of exams.
- The committee will review at the October meeting and vote on the issue at that time.

#### Wrestling weigh-in (Mike Moyer - NWCA)

- Currently, the NWCA recognizes that when a wrestler weighs in and is below the required percentage of body fat, they currently have to go back to a physician in order to participate.
  - o If this is approved as a recommendation then, it would need to be added to the bylaws.
- Mike Moyer stated that the gold standard would be (DXA) Dexa, Scan Body Composition, Air Displacement Plethysmography or Hydrostatic.
- Information from these tests is easy to enter into the online system.
- Mike Moyer suggested that the AIA staff keep track of the appeals.

• The committee requested that Dean Visser and David Hayward comprise wording for implementing this into the AIA Bylaws.

## NOCSAE Update (Javier Cardenas)

- The committee reviewed the recent press release from the AIA based on the recent NOCSAE and Riddell statements about the aftermarket products for helmets.
- These aftermarket products cannot be used and if the official determines that an aftermarket produce is being used, it will be a 15 yd penalty per the NFHS Football Rule Book.

# AIA Bylaw 23.5 (Chuck Schmidt)

- AIA Bylaw 23 Football
- The committee reviewed the bylaw to see if there were any safety concerns with a student being allowed to play up to (30) football games in a season.
- The committee showed concern with the safety of athletes participating in so many games.
- The committee will table this issue until the next Sports Medicine Advisory Committee meeting and will invited the Football Sports Advisory Committee to attend the October meeting.
