AIA CELEBRATES 100 YEAR ANNIVERSARY AND DEMONSTRATES LEADERSHIP IN STUDENT SAFETY AND DIVERSITY

PHOENIX, AZ (February 5, 2014)

As the Arizona Interscholastic Association celebrates its 100-year anniversary, the AIA Executive Board has made several key decisions that impact student safety and ensures diversity in student participation and school representation.

Student Safety — The AIA Executive Board determined that despite lagging decisions from national level organizations, use of aftermarket helmet sensor devices will <u>not</u> be considered a violation of NFHS Football Rule 1.5.1. AIA member schools have been given the opportunity to determine the value and efficiency of such devices (e.g. Shockbox) and their use in furthering a healthy and safe environment for those participating in football. "In the interest of student safety, we simply felt member schools needed to be empowered to make these decisions. The initial rule's intent was to prevent the use of performance enhancing equipment that would create unfair advantages. This clearly was not the case with these devices."

Diversity, Opportunity and Representation – In 2011, the Executive Board instituted processes to promote diverse representation on the various member school committees. The process directed that conferences or regions submit at least three nominations of which at least one be a person of color, one female, and one male. To encourage opportunity, the AIA Executive Committee has chosen to make this a requirement for all open committee positions. "As our communities change and grow, it is of the utmost importance to create diverse representation and opportunity within our committees to best represent each conference and region. Having multiple perspectives creates better decision making and greater inclusion," says Executive Director, Dr. Harold Slemmer.

This action follows the recent Racial Sensitivity Summit conducted on January 13, 2014 with leaders from the northeast region. The Summit tackled racial tension, changing community demographics, social economic challenges and how to create a culture in which all games are played with a sense of respect and honor.

The open event generated a cross-cultural dialogue to produce ideas to engage the parents, enhance and communicate AIA expectations and consequences for inappropriate behavior.

The AIA and its member schools desire to lead the way in creating this dialogue. Dr. Slemmer explains, "These can be difficult topics for any organization to take on, but we are a 100 year old organization with a rich history of teaching and creating an ethical culture that encourages student participation and ensures fair and equitable competition in interscholastic activities. It is our responsibility to take a leadership role to address the contemporary needs and challenges of our member schools."

Further events and announcements will be made throughout the year.

Since 1913, the organization has created and sustained interscholastic activities that encourage maximum student participation by providing AIA member schools with an even playing field to ensure fair and equitable competition. 

AIA EXECUTIVE BOARD - PROPOSED AMENDMENT

Amend AIA Bylaws: Article 6. Executive Board Section 6.1 AIA Executive Board Members Section 6.2 Terms of Office Section 6.6 Committees of the AIA Executive Board (Pages 12-19)

Rationale for Proposed Amendment

As noted in the proposed bylaw, the goal of this amendment is to formalize and "codify" the goal of promoting diverse representation in the membership of the Executive Board and AIA committees, with the belief that it is in the best interest of all AIA members that the composition of the Board and committees should take into consideration and strive to reflect the demographics of the membership and State of Arizona.

(Delete/Add Text)

- 6.1 AIA EXECUTIVE BOARD MEMBERS There shall be nine voting members consisting of:
 - 6.1.4 A member of the AIA Executive Board may not be a member of the AIA Legislative Council.

 Additional qualifications and the right of a representative to succeed himself/herself shall be at the discretion of the appointing or electing body.

6.2 <u>SELECTION & TERMS OF OFFICE - AIA EXECUTIVE BOARD MEMBERS</u>

- 6.2.3 Each representative shall be chosen at the regularly scheduled Executive Board meeting in April, no later than the first day of April preceding the beginning of his/her term of office and shall serve until a qualified successor is duly designated.
- 6.2.4 The selection of each Conference or organization represented representative on the AIA Executive Board shall, at the time and in the manner that it selects its regular representative, designate an alternate representative who shall serve in the event of a vacancy. shall be based on the following process in order to promote diversity and equity of representation to the AIA Executive Board:
 - Nominees must represent AIA member schools in good standing. If a school fails to maintain their standing, committee representation by that school is not permitted.
 - In an effort to promote diverse representation in the membership of the Executive Board, the following process has been instituted by the Board. It is designed to encourage and foster the policy that the composition of these groups should mirror the demographics of our member schools and state.
 - Schools will submit nominations for the Executive Board when the applicable conference or organization chair is open. The Conference or organization will submit three nominations, of which at least one must be a person of color, one a female and one a male. The Executive Board will make a selection from one of these three nominees.
 - 4. If, during a Board member's term, he or she is unable to meet his/her commitment, steps 2 and 3 will be followed in order to select a replacement.

6.6 COMMITTEES OF THE AIA EXECUTIVE BOARD

6.6.3 Diversity and Equity Policy -

- Nominees to AIA committees must represent AIA member schools in good standing. If a school fails to maintain their standing, committee representation by that school is not permitted.
- 2. In an effort to promote diverse representation in the membership of AIA committees, the following process has been instituted by the Board. It is designed to encourage and foster the policy that the composition of these groups should mirror the demographics of our member schools and state.
- 3. <u>Individuals appointed to serve on AIA committees shall meet one or more of the following requirements:</u>
 - a) an employee of a school district as an administrator, supervisor, teacher or coach;
 - b) be an AIA registered high school official.
- 4. Whenever possible, when conferences or regions submit nominations for committee membership, they must submit three nominations, of which at least one must be a person of color, one a female and one a male.
- 5. If, during a committee member's term, he or she no longer meets at least one of the criteria in Section 3, eligibility for committee membership ceases and a replacement shall be appointed. In the case of an unexpired term, the region of the former committee member is contacted to submit replacement nominations for approval by the Executive Board using the guidelines in Section 4. Should no nominations be received, the other regions in that conference are contacted to submit their nominations. When the appointment is made to fill an unexpired term, the appointee shall be eligible to serve an additional term provided the appointed term is less than three years in length.
- 6. All full terms for sport advisory committees, activities committees, conference and other general committees will be three years. A full term shall mirror the corresponding term of the conference and/or organizational Board Members term.
- 7. Committees shall serve at the discretion and pleasure of the Executive Board.

7. FINANCES - ASSESSMENTS

AIA EXECUTIVE BOARD - PROPOSED AMENDMENT

Amend AIA Bylaws: Article 9. Finances, Section 9.2 Assessments (Page 21)

Rationale for Proposed Amendment

Seeks to clarify that "demonstration, exhibition type events" are not intended to be covered under this section, which provides for catastrophic injury coverage.

The AIA Executive Board passed this legislation as emergency legislation on 11/18/13

(Add Text)

9.2 ASSESSMENTS

9.2.2 Student Excess Accident Insurance - Each member school (full and associate members) shall purchase excess accident (catastrophic) insurance to insure students against injuries sustained while engaged in school sponsored interscholastic sports and activities sanctioned by the AIA during the season of sport or activity as identified in the AIA Constitution and Bylaws. Demonstration and/or exhibition events (e.g., home run derby, slam dunk competition, three point shooting competition, closest to the pin competition, etc.) are not considered "sports and activities sanctioned by the AIA" and will not be covered by the catastrophic insurance referenced in this bylaw. The AIA Executive Board shall determine the insurance carrier for said coverage and notify member schools (full and associate members) of the carrier selected and the premium rate. Each member school shall pay the premium to the AIA office who, in turn, shall send a payment to the insurance carrier to cover the total annual premium for the member schools. It is understood that the AIA and the AIA Executive Board are not agents or representatives of, or in any way affiliated with, said insurance carrier. The insurance carrier shall set the terms and conditions of said coverage and AIA shall not be liable for any claims related to the terms and conditions of said coverage. (Ex. Bd. 11/18/13)

8. POST-SEASON TOURNAMENTS

AIA EXECUTIVE BOARD - PROPOSED AMENDMENT

Amend AIA Bylaws: Article 12. Post-Season Tournaments, Section 12.1 Post-Season Tournaments (Page 28)

Rationale for Proposed Amendment

The following process outlines a tie breaking process that is consistent with current alignment and classification structure.

The AIA Executive Board passed this legislation as emergency legislation on 10/21/13

(Delete/Add Text)

12.1 POST-SEASON TOURNAMENTS

- 12.1.6 AIA Tie Breaking Procedure Proposal ALL SPORTS (Ex. Bd. 10/21/13)
 - 1. Head to Head (Regular Season)
 - Regular Season Win Percentage Within Your Schools Division
 - 3. Regular Season Win Percentage in All Games
 - 4 Total Opponent Victory Points Divided by Number of Counting Games
 - 5. Total Opponent Opponent Victory Points Divided by Number of Counting Games
 - 6- Coin Flip (if for seeding only)
 - Mini Playoff (if to get into the tournament)
- 12.1.6 How Section Champions/ Automatic Qualifiers are Determined (Ex. Bd. 10/21/13)

For purposes of determining the section champion/automatic qualifiers for the state tournament (section or super sectional tournament in basketball), it is based first on win percentage within section games only. Therefore, the section standings are sorted based on section win percentage.

If teams are tied on section win percentage, the tie breaker is as follows, and will be noted on the standings pages as such:

- 1. Head to Head in Section Games
- 2. <u>Division Win Percentage</u>
- 3. Overall Win Percentage
- 4. Overall Power Ranking
- 5. Coin Flip if simply to break a tie for seeding
- 6. Mini playoff if to get into the tournament

Seeding Tie Breaking Procedure for Team Sports

For purposes of determining the seeding in team sports for AIA related brackets, the first criteria is the AIA Seeding powered by MaxPreps.

If teams are tied at season end in the AIA Seeding powered by MaxPreps, the tie breaker is as follows:

- 1. Head to Head
- 2. Division Win Percentage
- 3. Overall Win Percentage
- 4. Coin Flip if simply to break a tie for seeding
- 5. Mini playoff if to get into the tournament

9. STUDENT ELIGIBILITY RULES – ENROLLMENT RULE

AIA EXECUTIVE BOARD - PROPOSED AMENDMENT

Amend AIA Bylaws: Article 15. Student Eligibility Rules, Section 15.3 Enrollment Rule (Page 37)

Rationale for Proposed Amendment

The below language aligns policy with bylaw interpretation and practice.

(Add Text)

15.3 ENROLLMENT RULE

Only students enrolled at a member school in grades 9 through 12, inclusive, shall be eligible for interscholastic competition, team practices and tryouts.

10. <u>STUDENT ELIGIBILITY RULES – DOMICILE RULE</u>

AIA EXECUTIVE BOARD - PROPOSED AMENDMENT

Amend AIA Bylaws: Article 15. Student Eligibility Rules, Section 15.5 Domicile Rule, Section 15.14 Hardship (Form 15.10), Section 15.15 International Student Eligibility (Page 39)

Rationale for Proposed Amendment

Intended to clarify any conflict which may have previously existed between this rule and the "international student rule", and to state that a guardianship will not, in and of itself, grant an international student varsity athletic eligibility.

The AIA Executive Board passed this legislation as emergency legislation on 4/15/13

(Delete/Add Text)

15.5 DOMICILE RULE

- 15.5.3.2 <u>Legal Guardian</u> <u>Except in the case of a foreign exchange student or an international student under 15.15, a</u> student for whom a legal guardian has been appointed by a court of competent jurisdiction may be declared eligible at the school in the attendance zone in which said legal guardian is domiciled by petitioning as outlined in the AIA Bylaws under Article 15, Section 15.14 Hardship. *(Form 15.5.3).* For purposes of this rule, a court of competent jurisdiction does not include courts outside the United States. (Ex. Bd. 4/15/13)
 - 15.5.3.2.3 A hardship request based on a legal guardianship shall not be approved when the AIA Executive Board determines that athletic participation or circumvention of AIA domicile requirements is the reason for the legal guardianship.

Where it is determined by the Executive Board that athletic motivation and/or circumvention of AIA domicile requirements is involved in the legal guardianship, this is sufficient in and of itself for denial of the hardship request (see 15.14.2.4). (Ex. Bd. 4/15/13)

11. <u>STUDENT ELIGIBILITY RULES – DOMICILE RULE</u>

AIA EXECUTIVE BOARD – PROPOSED AMENDMENT

Amend AIA Bylaws: Article 15. Student Eligibility Rules, Section 15.7 Physical Examination Rule (Page 40)

Rationale for Proposed Amendment

Related to issues of access and availability of providers, broadens the disciplines of practice who are permitted to perform PPE's, including naturopathic physicians, and, at the discretion of the member school, certified chiropractic sports physicians.

(Delete/Add Text)

15.7 PHYSICAL EXAMINATION RULE

A student shall not be allowed to practice or compete in interscholastic athletics until there is on file with the principal or his/her designee a record of a preparticipation physical examination (PPE) performed by a doctor of medicine (M.D.), <a href="mailto:an-align: an-align: an-alig

NOTE: In order to assure safe and appropriate physical evaluation of prospective high school athletes, individuals who perform examinations of prospective high school athletes should be licensed health care providers whose education, training and experience assure the ability to assess prospective athletes on a systemic basis. Examiners shall be qualified to perform a complete physical examination, including comprehensive evaluation of the following organ systems: circulatory; respiratory; genito-urinary; neurological; and musculo-skeletal. All such health care providers must be licensed in the United States to prescribe all classes of medications in order to fully understand the impact various pharmaceuticals may have on a prospective athlete. (2/17/92)

12. STUDENT ELIGIBILITY RULES - HARDSHIP

AIA EXECUTIVE BOARD - PROPOSED AMENDMENT

Amend AIA Bylaws: Article 15. Student Eligibility Rules, Section 15.14 Hardship (Form 15.10) (Page 41)

Rationale for Proposed Amendment

Provides that the international student eligibility rule may be appealed under the hardship rule, which allows the Hardship Appeals Committee and/or the Executive Board, to consider eligibility exceptions on a case-by-case basis, for example the case of refugee status, or similar situation.

The AIA Executive Board passed this legislation as emergency legislation on 4/15/13

(Delete/Add Text)

HARDSHIP (Form 15.10) - In individual hardship cases the AIA Executive Board or the Hardship Appeals Committee may, at their discretion and upon such terms and conditions as may be imposed, waive or modify the Enrollment Rule (Article 15, Section 15.3, Paragraph 15.3.5 only), Domicile Rule (Article 15, Section 15.5), Maximum Participation Rule (Article 15, Section 15.9, Paragraph 15.9.1 only), Transfer Rule (Article 15, Section 15.10), and/or Recruitment Rule (Article 15, Section 15.12.4.14 only), and/or the International Student Eligibility Rule (Article 15, Section 15.15.2 only). The appeal shall initially be heard and decided by the Hardship Appeals Committee. The decision of the Hardship Appeals Committee shall be final unless appealed to the AIA Executive Board within ten days from the date of said decision. AIA Executive Board consideration of such appeals will take place only at a regularly scheduled monthly meetings unless otherwise scheduled by the Board. (See Article 6, Section 6.3 regarding procedures for meetings of the AIA Executive Board.) Procedures for appeals to the Hardship Appeals Committee shall be as determined by the AIA Executive Board. (Ex. Bd. 4/15/13)

13. STUDENT ELIGIBILITY RULES – INTERNATIONAL STUDENT

AIA EXECUTIVE BOARD - PROPOSED AMENDMENT

Amend AIA Bylaws: Article 15. Student Eligibility Rules, Section 15.15 International Student Eligibility (Page 50)

Rationale for Proposed Amendment

Intended to clarify that the international student eligibility rule applies to all international students other than foreign exchange students.

The AIA Executive Board passed this legislation as emergency legislation on 4/15/13

(Delete/Add Text)

- 15.15 <u>INTERNATIONAL STUDENT ELIGIBILITY</u> Prefatory Statement: In an effort to preserve and promote interscholastic competitive opportunities for Arizona students and further the goals of competitive fairness and equity, and recognizing the concerns of AIA member schools related to displacement of Arizona students by students from foreign countries, the following bylaw addresses the interscholastic eligibility status of international students attending an AIA member school:
 - 15.15.2 International Students: An international student is a student who is in the U.S. under an F-1 Visa any Visa or document other than a J-1 Visa and who is attending an AIA member school. Except as stated below with regard to domicile, an international student must meet all eligibility requirements of any regularly enrolled student. An international student is eligible only for non-varsity level competition, which may include only 9th through 11th grade, and is not at any time of enrollment eligible for varsity level competition. With regard to domicile, an international student's non-varsity eligibility shall be at a school in the attendance zone of the home in which the student is placed. (Ex. Bd. 4/15/13)

14. PENALTIES AND APPEALS - SPORTSMANSHIP RULE

AIA EXECUTIVE BOARD - PROPOSED AMENDMENT

Amend AIA Bylaws: Article 16. Penalties and Appeals, Section 16.3 Sportsmanship Rule (Page 54)

Rationale for Proposed Amendment

Provide an opportunity for a closer look at an ejection.

(Add Text)

16.3 **SPORTSMANSHIP RULE**

16.3.1.1.5 Players or coaches ejected in a contest that has a bearing on participation in a state championship tournament may appeal that ejection through the State **Commissioner of Officials.**

- 16.3.1.1.5.1 A contest defined as one having a bearing on a state championship is as follows:
 - Last regular season contest Sectional contest
 - b)
 - c) **State tournament contest**
 - The winning team in a-b-c above
- The procedure of hearing an appeal will be as follows: 16.3.1.1.5.2
 - Appeal must be filed within 24 hours of the contest
 - The State Commissioner will form a committee of officials/evaluators to review the ejection and any available game film
 - c) The decision of the appeal committee is final

15. OFFICIALS

AIA EXECUTIVE BOARD - PROPOSED AMENDMENT

As recommended by the Officials Task Force Advisory Committee

Amend AIA Bylaws: Article 18. Officials, Section 18.3 Fees/Schools – Official's Responsibility (Page 64-65)

Rationale for Proposed Amendment

- We have experienced a continuing drop in registration of officials over the past three years. We are currently down 13% in the period of January 8, 2013 to January 8, 2014. This drop can be attributed to the following:
 - a) Competition from other officiating entities that pay a higher game fee than the AIA.
 - b) Increased costs incurred by officials over the last three years related to officiating for the AIA
 - 1. Instituted required Fingerprint card to register (2011)
 - 2. Registration Fee Increase (2012)
 - 3. Added \$1.00 per game assigning fee (2013)
- 2) Our drop in officials registrations from the end of the 2009 season (last fee increase) to January 2014 is 21.5%.
- 3) Officials have the opportunity to officiate for other entities (charter league, city league, youth club leagues, etc), do multiple games for more money than we can currently pay for the same amount of time involved.
- 4) This fee increase was approved by the Officials Task force that met three times in the Fall to address pay issues for officials.

31. 1.4 Weight Certification Model

- 31.1.4.1 Alternative 1 The AIA and its member schools will use of the following guidelines based on the National Wrestling Coaches' Association (NWCA) Weight Certification Model:
 - Minimum body fat of 7% for males and 12% for females, determined by bio-impedance weighing;
 - Body hydration level (specific gravity) equal to or less than 1.025 g/ml.
 Urine test is pass/fail.
 - Establish an "alpha" weight (weight at time of bio-impedance initial assessment) for each wrestler;
 - If a wrestler's body fat is less than 7% (male) or 12% (female) at the initial weight certification, and the wrestler passes the hydration test, their "alpha" weight will be the lowest competitive weight allowed:
 - Collection and input of testing data into the NWCA Weight Certification Model will be done by AIA approved assessors.

31.1.4.1.1 <u>Appeal Process</u> (For Alternative 1 ONLY):

- A wrestler may appeal ONCE the results of his/her percentage of body fat used to calculate his/her minimum competitive weight certification;
- If a wrestler disagrees with the body fat percentage as measured with bio-impedance, the same assessor will remeasure that person ONCE within ten (10) calendar days;
- The wrestler's original weight will be used; only the bioimpedance body fat percentage will be re-measured.

31.1.4.1.1 Appeal Process

Any athlete who disagrees with the Initial Assessment may appeal the assessment results ONE time by having a second assessment with in 14 calendar days and performed prior to the athletes first Regular Season wrestling Contest. This shall be consistent with the athlete's weight loss decent plan and the results obtained at the Second assessment shall supersede the Initial Assessment; therefore no further appeal by any party shall be permitted. The second assessment shall utilize either Air Displacement Plethysmography (Bod Pod) or Hydrostatic Weighing testing to determine body fat percentage. All costs incurred in the second assessment

$\underline{\text{shall be the responsibility on those appealing the initial}}$ Assesment.

31.1.4.2 Alternative 2 -

A wrestler may choose to have his/her minimum body fat of 7% for males and 12% for females measured by his/her physician. The physician must complete the data required on the NWCA wrestling weight certification initial assessment form.
