- Treasurer's Report
 - The current region balance is approximately \$6,972.41 due to the deposit of check from the fall region championships' revenues.
 - We expect the account to increase. The increase was result from the following deposit:
 - Alchesay – David sent the check to Hopi (Ricky) forward the check to be deposed in the amount of \$1,258.95.
 - All the expenses have been paid from our winter championships SY 2019/20. Region account balance does not reflect the paid invoice of All-Region Hoodies.
 - Nuvayokva Ink have completed the All-Region Hoodies as of last week. They were delayed because their vendor originally sent purple hoodies instead of charcoal grey. The cost of the hoodies will be close to \$3,000.00. Ricky will be making the deliveries to the schools that are receiving items.
 - With those anticipated expenses and revenues, the region should start the 2020-21 school year with close to \$4,000.00 in the account.

The 2A Conference has met on two hardship appeals. One for football and volleyball. Conference and AIA leadership have expressed that all athletic directors to include completed required

paperwork when submitting hardship appeals to be present to appeal committee. Appeals committee would need these documents to make a fair and valid decision.

Winter hardship appeal deadline is October 19, 2020.

- AIA 2020 Modifications
 - Fall Sports – All AIA modifications are available on the aiaonline.org website and in your AIA admin portal.
 - Modifications will be in effect for the rest of the SY 20/21. Updates will be distributed and made available from AIA leadership.
 - Winter Sports modifications are forthcoming.
 - Local School Districts have the option to take the safety precautions one step further when conducting practices and competitions. For example, Phoenix Country Day school has implemented the AIA and District Governing Board policy to require face coverings at all times (practice and competition).
 - AIA Covid-19 Return to Play Form – SMAC was suggestive when a student is returning to activity after testing positive for Covid-19. Form is an evaluation for the athlete and primary care provider.
- 2020-21 Athletics' Seasons
 - Football
 - Conference Leadership requested survey to be completed.
 - Volleyball
 - Monday, August 31 – first practice
 - Monday, September 21 – first competitions
 - Thursday, November 5 – last day of regular season competitions
 - Tuesday, November 10 – play-in games at higher seed
 - Saturday, November 14 – rounds of 16 and 8 in Phx, sites determined by the AIA
 - Saturday, November 21 – semis and championship in Phx, sites determined by the AIA

2A Conference has requested to AIA for a neutral football site when competing for the championship in the Valley. St. Johns has expressed interest in this favor.

- New Business
 - Updates – Ricky
 - Executive Board – Met on September 2, 2020 for a special executive board meeting. Addressed decision as a board to adopt phase in approach for return to play activity. Return to activity documentation resource is recommended. Sports modifications are required and effective immediately for liability purposes.
