WINTER SPORTS

Discussion occurred regarding the Sports Medicine Advisory Committees (SMAC) recommendation to suspend the winter season of sport due to the current pandemic, rising numbers and hospital availability in Arizona.

A motion was made to move forward with winter sports on January 18, 2021 with the addition of mandatory face coverings at all times during competition. The motion was seconded and carried, the Executive Board <u>denied</u> the motion.

A motion was made to accept the recommendation from the Sports Medicine Advisory Committee (SMAC) and cancel the 2020-2021 winter season of sport. The motion was seconded and carried, the Executive Board **approved** the motion to cancel the winter sports season.

On a motion made, seconded and carried the Executive Board <u>approved</u> to postpone Spiritline competition and practice until the January 19th Board meeting.
